In particular, it was noted the necessity of analyzing several laws related to the norms of international humanitarian law, the subject of regulation, and preparing recommendations as a result of the analysis. The analysis of the legal basis of the treaty showed that Turkmenistan has ratified the Conventions regulating such areas in the field of international

humanitarian law. They include "On the Statute of Refugees," "On the Statute of Apartheids," "On the Prohibition of the development. production and stockpiling of Bacteriological (Biological) and Toxin Weapons and their Destruction," "Prohibition on the development, production, stockpiling and use of Chemical Weapons and on their destruction" and "The Optional Protocol to the Convention on the Rights of the Child."

Humanitarian promoted in the state policy of the President, who emphasizes that the main value of the modern democratic society is a person and its main goal is to ensure human well-being and happiness and the main principles are humanitarianism, justice and inspiration.
